The Northeastern Cave Conservancy, Inc. (NCC) is a not-for-profit corporation committed to the conservation, study, management, and acquisition of caves and karst areas having significant geological, hydrological, biological, recreational, historical, or aesthetic features.

To these ends, the NCC combines the resources and expertise of affiliated cave explorers, educators, scientists, landowners, and conservation officials.

The NCC programs are focused mainly on the preservation of caves and karst. Outreach includes education in schools and local communities, establishment of park spaces on karstlands, and educational messages about the significance of groundwater pollution on this sensitive underground ecosystem.

NCC members assist in the exploration, survey, and protection of these natural resources, and manage them so you

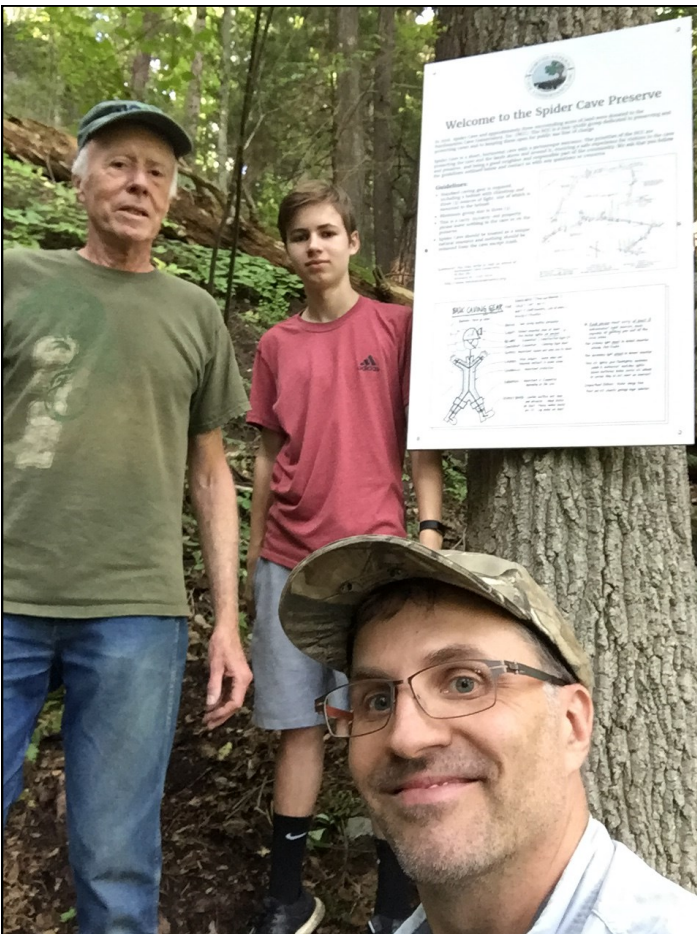

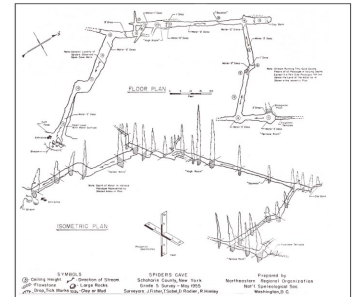
Welcome to the Spider Cave Preserve

In 2016, Spider Cave and approximately three surrounding acres of land were donated to the Northeastern Cave Conservancy, Inc. (NCC). The NCC is a non-profit group dedicated to preserving and protecting caves and to keeping them open for public use free of charge.

Spider Cave is a short, horizontal cave with a picturesque entrance. The priorities of the NCC are protecting the cave and the lands above and around it, ensuring a safe experience for visitors to the cave and preserve, and being a good neighbor and responsible part of the community. We ask that you follow the guidelines outlined below and contact us with any questions or concerns.

Guidelines:

- Standard caving gear is required, including a helmet with chinstrap and three (3) sources of light, one of which is mounted to the helmet.
- Minimum group size is three (3).
- This is a carry-in/carry-out property; please leave nothing in the cave or on the preserve.
- Spider Cave should be treated as a unique natural resource and nothing should be removed from the cave except trash.

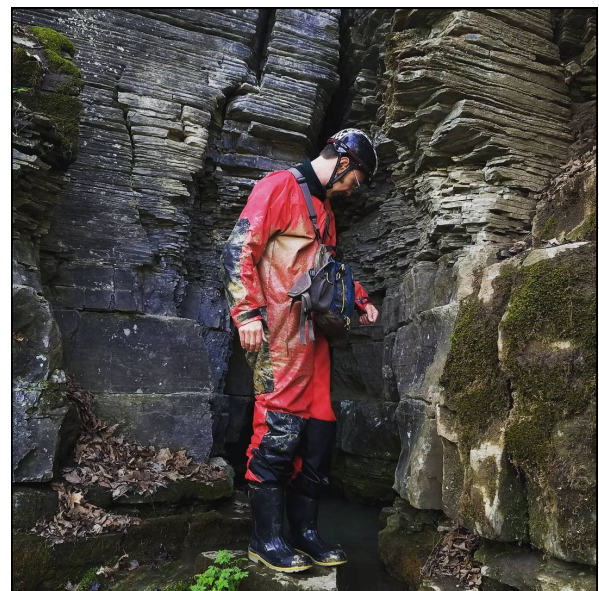
BASIC CAVING GEAR

HEADGEAR: Never go alone!

- BRANCH:** Take caving safety seriously!
- LIGHT:** Helmet-mounted plus at least two backup lights, one per person *
- HELMET:** Essential! (Construction type OK)
- CHINSTRAP:** Essential! Climbing-type best
- GLOVES:** Important! (Glove out also nice to have)
- LAYERS:** Wool, polypro - warm when wet. Nylon/wet suit in some caves
- COVERINGS:** Important protection
- KNEEPADS:** Important or Essential depending on the cave
- STURDY BOOTS:** Leather soles w/ mt. and abrasion - cheap boots die fast. Heavy rubber boots are OK. Lug soles are best

Darkness! (Wind and Noise!)
 FOR: COOL (Get it!)
 WET! (With Humidity, Lots of water)
 MUD! (Pleasant!)

* Each person must carry at least 2 independent light sources, each capable of getting you out of the cave alone.
 Your primary light MUST be helmet mounted, ideally, front (frontal)
 Your secondary light should be helmet mounted
 Think of lights: good flashlight, cyclotron, candle, w/ battery, matches, lighter (spare batteries, bulbs, parts, etc. should be carried, they do not count as sources!)
 Important Extras: Water, energy food, first aid kit, plastic garbage bags (batteries)

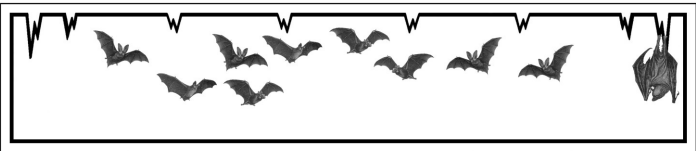

Devon Hedges was appointed manager of the Bentleys Preserve.

The Bylaw amendment to change the Officers' terms to two years was approved on its second reading.

From Committee Reports:

Office of the President:

- The NCC received a NYDEC/LTA Grant of \$4,700 for the acquisition costs associated with the Spider Cave Preserve. Hats off to Christine Young for spearheading this effort. Christine and I attended the award ceremony in Garrison, NY on April 26. It provided good visibility for the NCC.
- The NCC's Thom Engel was a seated guest at the opening ceremony of the new Thacher Park Visitor's Center on May 4. Nice work Thom! Also present were Bob Simmons, Mike Warner, Emily Davis, and Christine Young of NCC. We made some additional introductions to fellow land trusts and Thacher Park, and NYS Parks staff that were present. Thacher is very interested in our assistance with opening caves in the park to recreational activities.
- The NCC and our Caves were well represented to the recent NRO/MAR event in Pattersonville, NY, over the June 2 - 4 weekend. Many thanks to all who helped out and represented the NCC well. Between the auction, swag sales, and donations, we took home over \$1,200 for the weekend. I received numerous comments from the attendees, including many from the MAR Region about how great our preserves were. Mike Warner and Emily Davis gave a fantastic presentation on Bat Research and Cave Mapping in Fiji on Saturday night.

Bensons Preserve:

On April 17, the NCC hosted a very successful sinkhole cleanup with an AmeriCorps NCCC team at the Bensons Cave Preserve. Eighteen 55-gallon contractor bags of trash, as well as tires and other objects, were hauled out of two adjacent sinkholes not far from the Bensons Pit entrance. Approximately 800 pounds of garbage were removed. After an initial round of effort put forth when the preserve was first acquired in 2014, this is the last area of the preserve requiring trash removal, and significant progress was made towards its completion.

Technology Committee Report:

Volunteer Value Committee:

Year-to-date totals: 925 hours of volunteer work for NCC projects for a total value of \$26,372.00. Members also reported traveling a total of 3,277 miles to work on NCC projects.



NOMINATING COMMITTEE SEEKING CANDIDATES FOR OFFICER POSITIONS

Each year at the Annual Meeting in December, the Trustees elect the four Organization Officers (President, Vice President, Secretary, and Treasurer). Each year, the Nominating Committee presents a slate of candidates for these four positions for consideration by the Trustees. Nominations are also solicited from the Trustees. The Nominating Committee is looking for potential candidates for the Officer positions at this time. For reference, the general duties and responsibilities of the four Officer positions are described below.

President: The President is the Chief Executive Officer of the NCC, and supervises the activities of the NCC within the scope provided by the bylaws. The President presides at meetings of the Board of Directors. The following committees report to the President: Acquisitions, Preserves, Nominating, and Risk Management, as well as any ad hoc committees established for specific purposes.

Vice President: The Vice President assumes the duties of the President in the event of absence, incapacity, or resignation of the President, and presides when the Board meets as a Committee of the Whole. The following committees report to the Vice President: Bylaws, Education, Science, Special Use, Surprise Cave, and Thacher Park.

Secretary: The Secretary keeps the minutes of the meetings of the Board of Directors and of the Executive Committee, and maintains the membership roll. The Secretary also carries on all organizational correspondence as delegated by the President and sends out notices of meetings. The Secretary is responsible for editing and publishing the Board Manual. The secretary may appoint assistants, as required.

Treasurer: The Treasurer is responsible for the safekeeping of organizational funds; maintaining and reporting financial records and statements to the Board of Directors; and filing all financial documents required by local, state, or federal regulations. The following committees report to the Treasurer: Technology, Fundraising, Membership, Office, Publications, and Volunteer Value.

Summary Description

This position can be based anywhere in the Northeast.

As leader of the organization, the President and oversees the following committees: Executive, Acquisitions, Cave Preserves, Nominating, Risk Management, and several Ad Hoc Committees.

The President is responsible for providing dynamic leadership for the planning, development, implementation, assessment, and improvement of mission-related programs, revenue-generation and financial-management strategies, partnerships, community relations, legislative relations, marketing/public relations, strategic and annual planning, and other key areas.

The President serves as the primary spokesperson for the organization with funders and stakeholders. As part of the President's responsibilities, s/he will formally and informally present reports, updates, and results to the Board of Trustees on a periodic basis, which will include regular Board meetings and specific committee meetings of the Board.

The President will be responsible for supporting the development of and advancement of a vision for the NCC's impact in the region, for its continuing growth, for ensuring financial viability, and for building collaborative relationships in the Northeast.

Specific Responsibilities

As chief executive officer of the land trust, the President is responsible for the efficient operation of the land trust.

This shall include performance of, or timely delegation to the Vice-President or other officer the following duties:

Chairs quarterly Board and Executive Committee meetings.

Facilitates the orderly transaction of land trust business and the attainment of land trust purposes, including the proper functioning of standing committees.

Signs policy and fiscal documents with prior authorization from the Board of Trustees.

Signs routine administrative documents, such as reports on behalf of the land trust Board, and letters relating to fundraising and similar activities.

Is the principal representative of the land trust at public functions.

Seeks, obtains, and transmits regular reports from land trust committees.

Sets overall land trust priorities, including short-term and long-term goals, with other members of the Board.

Actively works together with the Acquisitions Committee on acquiring new cave preserves.

Actively works together with the Cave Preserve Committee on stewardship matters.

Performs other duties at the request of the Board of Trustees.

Proactively cultivates and solicits donors and prospects, and works toward annual fundraising goals.

Specific Responsibilities
