Attachment A PRESIDENT'S REPORT

12/02/00

- 1. My efforts with the Acquisitions committee have been the most fulfilling, but not completely successful by getting donations. Both the Carlisle Ice Cave and the Selleck's-Levy's properties remain in my mind worthy projects, so I have but them on the agenda to get a sense of the Board about these two specific projects.
- 2. West Virginia member Aaron Jarvis works for Allegheny Energy, and his employer has an Environmental Stewardship Matching Grants Program. If Aaron can work 2-5 hours per month as a volunteer for us, Allegheny will give us \$250 for the year. Up that to 5 hours/month, and we get \$500 for the year. Although modest, I think it's a great start, and I wonder aloud how many other employers have similar programs that could benefit us.

Help us find tasks for Aaron, particularly in Pennsylvania. He can represent us as a liaison with PA cave conservancies, and he can also do any photocopying of documents that need on an occasional basis (not the newsletter). Allegheny <u>might</u> ask for an audited financial statement from a CPA, and ours is a very simple one. Anyone know a CPA?

I'll have copies at the meeting of Allegheny's program.

- 3. I have come across a service to enable the NCC to accept credit cards at a reasonable rate. One calculation says it will take \$41 in fees when we take in \$500 per month. At 8.2% fee, it sounds high, but consider that we will have \$459 more dollars that month than without this service. Consequently, I have put an item on the agenda to have the officers work with the Office Committee to check other sources, hammer out the best deal for us and proceed. This one is called Northern Merchant Services from Galway, NY, and we have found others. Think about what the Southeastern Cave Conservancy has done with this scheme, and I think you'll give it a chance.
- 4. I'm suggesting that the NCC in many instances-Executive meetings of the officers, the newsletter, preliminary agenda-set deadlines and meeting dates so that things don't get overlooked. I'm also suggesting that new Executive Committee meet in between our regular meetings, and one topic for the EC might be to assign committees to each officer to oversee and keep on a timetable.
- 5. Having said all of the above, I see a greater urgency to find a chairman for our Fund suddenly available to us, and several other plans could be utilized. Help me jump start this important committee, find a leader or co-leaders.
