# ATTACHMENT A PRESIDENT'S REPORT December 14, 2003

The big news is the rapid progress made by the Acquisitions Committee to acquire about 11 acres around Clarksville Cave. We have a basic written agreement signed by June Alberts representing the 3 sister-owners and also signed by myself. Probably it is not a total and legal binding document, one reason being the clause that the NCC Board must approve any final agreement and all 3 sisters must sign. Mike Breen of Middleburgh is on board as our attorney, and his office will prepare a final agreement. Mike will have to have the survey drawing showing the subdivision and the legal description of our parcel.

The survey has commenced and it is possible that the field work can be completed before the heavy snows blanket the ground. This leaves the drawing and legal description for them to do, so that part of it should not take very many weeks into 2004. One good selling point to the Alberts was that our survey would be around the entire parcel and thus would serve as a finished survey should the Alberts ever sell in the future. Or it would be a good base for future subdivisions for the Alberts if they choose that route. In all case, our survey has value to them.

Chuck Porter and I have a very positive visit with the Town of New Scotland's Building Inspector, Paul Catlin. This could be the only town in New York State where the entire subdivision process is approved by the Building Inspector - no public announcements, no public hearings in front of a commission. The 3 or 4 pages of surveying and environmental requirements seemed very straightforward. In fact, one form was nearly completed during our visit to his office!

Part of the agreement mentioned above is that the owners will construct a gravel parking lot on our new land. We have a verbal agreement that in the immediate future we will continue to use the existing upper parking lot, but out of all of this we will get a new parking lot.

Elsewhere you will learn of exciting news from the Fund Raising Committee. Bill Folsom has been working with Alan Traino to get a good method for the NCC to accept credit card donations. The Office Committee reports a very encouraging burst of donations, some in the hundreds of dollars, upon hearing of the Clarksville agreement (through the underground?).

Not to ignore other possible acquisitions, you will hear of progress on several fronts.

All in all, there is forward momentum in the NCC, and it is exciting! Cavers are stepping forward to help in many ways, donating time, talent, and money. These are good days as the NCC moves into its fifth year as a member-based organization. Thanks to all of you.

#### NCC to accept credit cards

I am working with Alan Traino on getting this set up. My role is to run the software that we will run monthly that will debit those NCC members who wish to donate a specific dollar amount over time. The software will also be able to handle one-time charges such as special donations and yearly NCC membership dues. The software package was recommended by Bill Stringfellow who handles this currently for the SCC. The name of the program is PC Charge Pro and is installed on my PC ready for the specific credit card payment processor we end up going with. Note that Alan Traino donated the cost of the software in order to speed up the process so we are ready to fundraise for Clarksville.

# Preparations for potential NCC acquisitions in Northeastern states other than New York

Dan Werner, NCC Legal Committee Chair notified me that he believes we need to register as a foreign corporation in any state in which we own property. I have started the process for VT and will leave it up to the Board when we spend the money for this, as it does cost \$125 on a yearly basis as well as a \$125 up front filing fee. Next on my list would be MA, CT and then NJ, but we do not need to register until we have a pending acquisition.

Dan also writes that the NCC may want to consider registering as a formal Charity in New York State:

The Charities Bureau itself is fairly helpful answering questions about whether you need to register, and if so, how to register. You may want to give them a call directly. It may be that NCC is under the \$25,000 threshhold for filing the annual report, but as NCC grows (hopefully!!!), you all should look closely at the registration requirements.
