# PRESIDENT'S REPORT 12/05/04

NEWS FLASH! On 11/27, the Office Committee received notice that the NCC has successfully been registered as a nonprofit corporation in Vermont. This means we now need some caves to manage, and more importunately, local management teams to do the real work. Thanks to Bill Folsom for carrying through on the paperwork despite some setbacks.

At the recent NCC Executive Committee meeting, the Officers talked about growing pains of our group. Yes, we are growing, and yes some problems are being noticed because of that. To address the issue that perhaps are meetings are too long (and dare I say, boring?), we are trying a new system whereby each Officer and Committee Chair will submit their reports in writing 2 weeks before the meeting so that the Secretary may include them on the agenda. By reading the reports ahead of time or at the meeting, the EC hopes to streamline the meeting by cutting down on the amount of time spent in verbally presenting them. At the meeting, the President will ask the committees if there are any last minute updates, and then he will ask for questions or comments on the written report and verbal updates. It will be the President's job to limit the discussion because important items will find their way onto the agenda as motions. If we need discussion, and often we do, The Committee of the Whole is the perfect venue for that since issues automatically become items of new business at that meeting.

The President will not accept oral reports at the meeting other that last minute updates. "Status Quo" or "Nothing to report" is a valid response, but hopefully not too many meetings in a row! By this new system, we hope to cut down on the time spent in reports. The EC feels that it is each of the volunteers' responsibility to think ahead a little and write a brief report. Yes, the final agenda will become a longer document, but it will contain concise reports. In the end, everyone should benefit.

Personally I like reading all the reports on the agenda, and we might even print the Board member's justifications or reasoning underneath each new motion if it is not obvious. I'll be interested in your comments on this process.

## Update on establishing an NCC legal presence in other states

Corrected paperwork has been resubmitted to VT as of 11/15 and I expect no problems this time around. CT, MA and NJ have more expensive yearly fees, so when an acquisition is pending we can apply as a Foreign Corporation at that time.

# Pompey's Cave in Ulster County up for sale

Alan Traino and I had a very nice chat with the owner of Pompey's on 11/16. He is very open to hearing an offer from the NCC on his "worthless" streambed over the cave. We then visited both the Town Clerk to get the tax map, then the Code Enforcement/Zoning Office where we found that it should be a slam dunk zoning-wise. The new lot we would create has 170 feet of frontage. This is in the Town of Rochester in Ulster County.

Note this is the longest cave in Ulster County, over 4,000 feet long.

With a digital tax map and the location of the cave known fairly well, as far as the surface is concerned, we should be able to carve off about 3 acres easily. We could get Brian Pease to do some radiolocation if needed also.

In conversation with the owner, he understands that BUILDABLE real estate in a nice spot in that area now goes for between \$10,000 and \$20,000/acre. We have to start somewhere realistic though -- Alan and I discussed an initial offer of \$12,000 (not with the owner - no figures were discussed with him) to start the ball rolling.

#### Plans

With Clarksville under our belt, the NCC is poised to evolve to the next level. I believe we need to increase our membership, increase community outreach and improve the design of our website in order to appear more professional to the world, cavers as well as non-cavers.

# Attachment D CLARKSVILLE REPORT

Problems: None so far.

Progress: General

Thom has now given out nearly 100 copies of the guidelines sheet (copies will be brought to the board meeting) and is now using version 2.0. Nothing but positive feedback has been encountered. As time permits, Thom will continue to serve in the steward position.

#### Kiosk

A kiosk was built at Clarksville during the October NCC community day event. It is 95% done, with the display case cover yet to be built. Because of this, no material has been put on the kiosk yet. Originally Craig mentioned that he may be able to arrange for free lexan from GE, but that fell through, now the frame for the display cover has been built but the lexan has not been purchased yet.

#### **Battery Recycling**

Leslie Hatfield suggested to Thom that a battery recycling location might be useful, and is willing to do almost all the work. The managers have agreed to it and plans are being drawn up to put such a battery box by the kiosk.

#### New Trail

A new trail from the future NCC owned parking area to the current path was designated and cut by Thom during the October community day. Ken Nichols helped further widen the path later in the day.

#### General Cleanup

All the fallen trees near the Wards sink area (& adjacent fire pit) were cut up by and moved to the upper parking lot during the community day as well. A large load of firewood has been taken to the Schoharie cabin, some has been taken to Mike's house (to get it off the Clarksville property), but some wood still remains on the upper lot. A large refrigerator has been properly disposed of by Thom, Ed, and Tom Rider.

#### Parking Lot

The 50'x50' parking area has been cleared, but is currently uneven and largely unusable. Sonny has now cut an access road across the back end of the parking lot. Thom suggests that we fence that back line when we get ready to start using the parking lot. (How much work is left to make it useable, and when to do it?)

Plans: The managers need to get together and discuss the long-term plans for bathroom/changing area and parking lot. Criteria under which we would assess the need for one needs to be determined. Right now, Thom is of the opinion that the situation does not warrant the cost (\$1200+per year). Chuck feels it would be best if this is one fairly uniform and good-looking building or set of structures. (Also things like shrubs and fences to both beautify and bound our property.) Mike agrees with Thom that the current situation does not warrant the recurring cost (for porta-johns), but would favor one larger bathroom & changing structure over porta-johns if it is determined that bathrooms are needed/wanted. Whatever is decided upon will not likely be built until the ground thaws in the spring; the three managers need to meet to determine the location(s).

Also we need to start planning for the stewardship program to get underway in the spring. This might mean some training for special steward leaders through John Lawton and having groups or grottos responsible for certain weekends.
