- 12. Science Committee Larry Davis no report received
 - Schoharie, Gage, Knox, Hailes got hit hard by bat mortality. Joe Installed data loggers in Gage, Schoharie and Knox. Al had a poster that was presented at the ?? ... What is the difference between the caves that had bats die and the caves that did not have bat deaths.. Can the problem be transported between caves and animals...possibility of closing caves or also possibility of eradicating the colony if there are problems.. Waiting for more information on the fungus that was found on the bats. Fungus did not kill them directly. Maybe warding off the infection they used up all their energy and died. So desperate that they moved to the front of the cave or even outside to get food.

13. Acquisitions Committee Report - Chuck Porter

Progress continues towards acquisition of Merlins Cave (formerly XTC and then Belknap cave) in Columbia County, NY. In October we hired an appraiser who valued the property at \$2500/acre; the owner and I agreed on preserve boundaries encompassing roughly 34 acres; and the owner is asking for \$85,750 for the parcel. We have made contacts with the Columbia Land Conservancy and hope that they will be able to assist us in reaching this goal. We also plan to conduct a bat survey early in 2008 and the results of that may lead to additional support if threatened or endangered species are found hibernating there. The neighboring landowner has verbally offered to give us parking space on his land near the deeded walking access route. A motion to purchase this property will be introduced at this (Dec. 9) meeting.

They have placed some no hunting signs at strategic places as there have been some neighborhood problems with hunters without permission in the area. Thanksgiving day and the morning after there was a car parked in the parking lot. When we checked we found recent trash including single use heat packs that were still warm. The car was gone.

Additions from Jay: I have ordered the property boundary markers, so hopefully this will help keep people from hunting on the property without permission in the future. Two signs with Knox specific wording on visitation guidelines are finished and will be put up at the cave entrance and near the parking area.

• The Education Chair attended the "Thacher Park Days" in October of this year. During this event, the karst groundwater hydrology model was utilized to demonstrate the properties of karst watersheds vs. typical non-karstified watersheds. Many families, groups, and individuals stopped by the NCC booth

to witness these displays, and some quite were surprised at how karst areas react to contaminant injections. This model was also used at an informal meeting of the Biogeochemistry Department at State University of New York's College of Environmental Science and Forestry, again to show some basic differences in watershed contaminant handling.

 - The 2yr website hosting contract with Brinkster expires in December 2007. With all the small
 problems that we have had with Brinkster over the last two years, I wanted to switch to a new
 hosting company. I have had an account at 1and1.com for 5+ years now, without a single
 problem.

This account has plenty of excess capacity to host the NCC website, so I decided in late November to initiate the switch, since sometimes it takes up to a few weeks to complete the process. To my surprise, the switch from Brinkster to 1and1.com was complete in just a few days, and finished without a hitch.

This switch allowed me to move a more reliable company and also switch the website database over to a mysql backend instead of a MS Access one, which generally works better with PHP (my preferred scripting language). With the mysql database, we can now use the phpMyAdmin interface software to interface with the database online. It is a fairly user friendly, excel-like database front end, similar to the existing "spreadsheet" mode of the website interface but much more powerful well tested to be bug free.

You can find a link to on the database resources page, or directly at http://www.necaveconservancy.org/phpMyAdmin . The existing login information should work on this as well.

In my opinion this interface is a good replacement for the existing software that I wrote for adding, deleting, and modifying membership information. One can also do simple and complex searches for information such as members from a given date, last names that start with "B", etc. It also allows for the edit/deletion of multiple entries at a time.

I had to re-enter all the email aliases with the new host. The new email system is a bit better than Brinkster's, with the ability to have automatic spam filtering if one wants it and also the ability to have an email address be both an alias and an actual address, instead of one or the other.

The hours of work performed by members is about 60% below this time last year. I think this is partly due to fewer large work projects undertaken by the conservancy and partly due to some members maintaining a personal log of volunteer activities with the intention of submitting the hours toward the end of the calendar year. Submitting data en mass is not a problem for me but

it does give the impression that we have "slowed down" when I report lower totals in my quarterly reports.

I wrote a short article for the newsletter and sent it to Mike Chu.

I sent a short overview of NCC volunteer activities to Scott Fee, NSS Fund Raising Chairman. He requested input for the Combined Federal Campaign (CFC) application he was working on. The CFC is one of the largest sources of donations to the NSS.

The web page to submit hours, http://www.necaveconservancy.org/add_vv.php is working very well and some members are using it regularly. I encourage all Officers, Committee Chairs and Property Managers to check it out.

Attachment A PRESIDENT'S REPORT 12/09/2007 Robert Addis

I don't seem to have much to report at this time although I assure people that I have been busy with NCC business. A significant part of my business has been my involvement with the Acquisition Chair on work for Merlins Cave (Formerly known as XTC Cave). This has been very exciting work for Chuck and me for a number of reasons. First of all, Merlins is a truly outstanding cave, a newly discovered marble cave of significant length. One knowledgeable caver ranked it as one of the top three marble caves in the United States! Whether that statement is true or not begs the question; Merlins is still a remarkable cave and one that has been offered to the NCC. I can't wait to visit the cave when it is permitted.

The second part of this exciting challenge is the fundraising. This will be twice as large as any previous NCC acquisition so it will mandate new methods, new resources. Chuck and I have expectations of cooperation with the Columbia Land Conservancy (CLC), the land trust who will hold a conservation easement on the parcel. We are hopeful that the CLC will introduce us to some fund raisers and fund raising methods that we haven't used in the past. I see this aspect as our greatest challenge; this truly represents growth on the NCC's part.

One other area of the pleasant acquisitions work I so enjoy was the researching of ownership of Novemberkill Cave, Albany County, NY as part of the Hailes Cave System and therefore part of our new relationship with the Thatcher State Park. Novemberkill you may recall as a small stream resurgence proven to be the low water flow route of the stream in Hailes Cave and a possible area to modify passage in an effort to prevent sudden flooding in Hailes and the resultant killing of the endangered Indiana bats. Hailes is clearly owned by the Park but Novemberkill's ownership is in question. My first attempts to contact the owner of record disclosed that he had died and the property had sold. Finding the new owner(s) has proved to be more difficult since there is corporate sheltering taking place.

Attachment B Vice President's Report For Dec. 9, 2007 Peter Youngbaer

It never ceases to amaze me how many e-mails circulate among the board, executive committee, and NCC members between meetings. It is not unusual for 20 a day – and, looking back over 2007, there were literally only six days without some NCC e-mail.

Since our last Board meeting, many of these communications have dealt with the Becker's Cave situation. As the VP, I've worked many long hours with the other EC members preparing grant documents, participating in phone calls, and writing summaries to help with fundraising. We've also had to respond to the legal communications sent out by the Administrative Law Judge and the other parties, including reading extremely lengthy documents – sometimes over 70 pages long. At all times, I have urged us to analyze and respond using our own talents, and those donated by others, rather than incurring additional legal expense. However, some communications require legal counsel, whether we like it or not. The New York regulatory process requires parties to communicate through their attorneys. This is extremely time-consuming, yet I remain convinced our work is appropriate and narrowly focused. It is unfortunate that, for the most part, we are in a reactive position, awaiting the actions of others.

Many other communications have involved the potential acquisition of Merlin's Cave (formerly Belknap's or XTC). Draft management plans, the appraisal process, and negotiations and potential fundraising have all been the subject of a lot of discussion. Kudos to Chuck Porter for the successful appraisal and for moving the process forward.

Similarly, discussions with NYDEC over Surprise Cave, Tory's Cave in Connecticut, and our own Acquisitions Policy have taken up my time.

Along with Jon Allison, we have been nudging the MHLC forward regarding the Gregory's easement at Clarksville. I am disappointed that we have not brought that to conclusion yet, but again, the actions of others are somewhat beyond our control.

One major push I have been working on is jump-starting the discussions with the Vermont office of The Nature Conservancy over the management plan for the Mount Aeolus Bat Cave. Several of the Vermont cavers had suggested various approaches, and at the last EC meeting (held in Rutland, VT), we decided that Peter Quick's idea of involving Al Hicks was worth pursuing. Graciously, Al took up the challenge following my briefing. Over the past few days, there has been a flurry of e-mail exchanges between Al, myself, Scott Darling (Vt. ANR bat biologist) and Susi vanOettingen (USFW). I've sent all of them the history and drafts of the management plan, the visitation plan, and the proposed MOU between TNC and the NCC. These documents are all over a year old, but they will serve to get us all on the same page again and moving forward. Scott and Susi indicated they would like to get a conference call together after Jan. 1, with an eye toward completing the plan and arrangements so that the cave can open again this coming summer. I hope we can discuss this situation briefly at the Dec. 9 Board meeting.

Finally, as VP and member of the Executive Committee, we get a ton of e-mails concerning much more mundane, though important, things like office reports, questions about our website, accounting procedures, budget development, recruiting for officers and committee positions, policy questions (such as our first-time use of the Science/research application), and much more. I welcome questions and feedback.

Income Taxes status

The financial discrepancy noted previously, discovered while doing the NCC's 2006 federal taxes, has been resolved. \$10,000 of the previously reported \$11,085 discrepancy was due to double-counting funds transferred from our local bank account to our NSF investment fund account at the end of 2005. Additionally, \$723 in investment appreciation of the funds kept with the NSF was not recorded properly on the 2005 return due to differing tax year-ends (the NCC uses calendar year, NSF ends year end of March 31st). The rest of the discrepancy (\$362) was due to differences in how the taxes were calculated.

Signed, completed forms were mailed in to the IRS before the November 15th extension deadline. Copies sent via email to the NCC Board also.

Thanks so much to Ayzha Wolf, Met Grotto Treasurer (and bookkeeper by profession), who unmasked the errors, and completed an Amended 2005 return (where the error was found) as well as completed the 2006 return. Ayzha now has all the NCC financial data in Quickbooks, so this type of mistake should not happen in the future.





Attachment F Proposed- CAVE AND KARST ACQUISITION POLICY

Overview:

The NCC Board of Directors (Board) shall consider acquiring properties that contain caves, cave entrances, or significant karst features when acquisition proposals and management plans are presented that are in line with the mission statement of the NCC. A cave purchase is a significant commitment of resources, which makes a very visible statement about the NCC's values and the significance of the cave properties to be acquired.

Developing proposals:

Proposals and management plans will include information and rationale as described in this policy and Appendix XII, "Writing a Cave Management Plan".

Proposals will be submitted to the Board by the Acquisitions Chair or a delegate there of.

The Following questions should be answered within an acquisition proposal:

- Significance Does the property to be acquired meet the NCC's mission statement? "The NCC is a not-for-profit corporation committed to the conservation, study, management, and acquisition of caves and karst areas having significant *geological, hydrological, biological, recreational, historical, or aesthetic* features." The proposal should state which of these mission statement objectives (highlighted in italics) are met by the property.
- Consequences of No Action Is there a negative consequence to the NCC taking no action to protect the property?
- Method of Protection Will the property be purchased, leased, donated, or managed by the NCC for another party?
- Cost What will the purchase cost the NCC? An appraisal should be done on the property in order to know the fair market value of the property. Are there any resources that could be sold to recoup some of the cost of the property or any portion of it which could be sold off? Will there be any ongoing operational costs?
- Survey Will a professional survey of the property need to be done?
- Liability Determine the Conservancy's liability under the recreation use and landowner protection statutes of the state where the property is located. Are there any physical hazards on the property which could increase liability? Any hazardous waste? Old garbage dumps that will need to be attended to?
 - Funding Does the NCC currently have enough funds to make the purchase or will there need to be fundraising?
 - Title Is there a clean title to the property? Title insurance should be purchased for all potential land purchases.
 - Management Plan A management plan should accompany the proposal as described in Appendix XII, "Writing a Cave Management Plan".

Research Letter of Agreement Template

When the NCC Board of Trustees approves a research project, a Research Letter of Agreement shall be signed by (The President; or The Science Coordinator) and the research applicants, and dated. The letter should reference the Research Application, and also the NCC Research Policy (Attachment H), and they should both be attached to the Letter of Agreement. Any specific conditions the Board feels necessary should be included in the Research Letter of Agreement.

Example
The Board of Directors of the Northeastern Cave Conservancy (NCC) hereby approves the research project entitled, which is attached and hereby incorporated into this Agreement. The researcher(s), by signing below, indicate they will abide by the project proposal as described in the attached project, and with the research policy (Attachment H), also attached and incorporated into this agreement.
Researchers shall provide a copy of any and all reports to the NCC, including the final project report and any published versions.
The Research Project is approved with the following conditions:
(NONE) Or 1. (sample) researchers shall report on statistics to the Science Coordinator every 6 months, beginning in April.
The NCC reserves the right to end the research project if there is any violation of the agreement by the researchers, or if some other circumstance requires it to protect our resource.
