 - Last few weeks things have been quiet. We have had problems on Saturday nights with parties in the cave and some incidents in the upper parking area, especially a few cases of what appeared to be human excrement. More disturbing were a couple of incidents in July when someone rolled a large rock into the Ward entrance. Since no one was in the cave at the time, this was not serious. However, the Albany Co. Sheriff's patrol was contacted and asked to keep an eye for vehicles at the cave at odd times.
 - After the leaves are gone we should schedule a workday to re-clear the trail on our property from our parking/changing area to the kiosk. Also clean out the parking area and build a sturdy fence across the north end of same.

 - I received a call from Ted Kerpetz, NY DEC concerning the NCC AANR application for Surprise Cave. He wanted to be sure that we were still interested despite the cave being closed. I responded that we were, and in particular that we were concerned about the gate, the ongoing lack of security and the impact to the surviving bat populations. I noted there were a number of projects and ongoing activity that was appropriate, even with the cave closed, including gate repair and monitoring, trail relocation, assistance with scientific studies, etc. Also, that someday, we presume that the cave will reopen once WNS has been solved and/or human visitation is absolved from blame, etc.

He promised that they would be reviewing our application shortly and we should be hearing something back in the next several weeks. His tone was very friendly and apologetic for this having taken so long.

Attachment A PRESIDENT'S REEPORT

The NCC has made some significant progress in several directions by taking small steps that seemed routine at first. Since our June 2010 meeting, it has become obvious to me that the NCC presence at caving and community events is very important and that there is a cumulative effect in benefits reaped versus meetings attended.

In chronological order, the NCC had the community-based opening ceremony for Bentleys, a booth at the NSS Convention in Vermont, a booth at the Old Timers Reunion in WV and our presence at the Fall NRO in Mass. Significant donations came in during this period - \$1,000 from Dick Blenz, \$500 from NRO and several individual's generous donations, perhaps more than normal in a recovering (?) economy. I believe the lesson learned here is to keep the NCC presence in front of both our membership and the community in general. I have started calling the NCC "one of the premier cave conservancies in the United States" and I sincerely believe it.

Although the legal research is funded by the NSS, I believe that the NCC will reap many benefits from the current study of cave rights in New York State. I will speak to them in the near future, but suffice it to say that they appear to be very powerful. These conceptions are not new – they date back to the "Cave Wars" around Mammoth Cave, KY in the early 1920's and were wisely captured by the Northeast's caving lawyer friend, the late Jim Gage in the 1950's. These are the cave rights presently under investigation by the NSS.

I am equally encouraged by forthcoming events, particularly the Knox Cave Barn Dance fund raiser. Successful at its conception in 2009, this annual event captures the imagination of the general public and gives us a venue to present information on cave conservation in a recreational/social setting.

Merlins – Chuck Porter, the Acquisitions Chair and I conducted an informational session with the Town of Canaan's Planning Board on 9/20 and accomplished our goal. The Planning Board will allow the owners and the NCC to do a partial land survey of just the property being transferred and not the whole parcel, a significant cost savings. We are presently working on an acceptable parking situation for the parcel; and we will get a walking access into the area.

We are at a point in the fund raising for Merlins where we are lessening the amount of money we have to borrow. We are essentially borrowing from ourselves and paying back likewise since we borrow against our assets held by the national Speleological foundation.

Attachment B Vice President's Report

The past few months since our last meeting have been filled with NSS Convention activities, but now that the Convention has come and gone, like most of you, I've been able to focus more on NCC activities.

I was charged with contacting the TNC folks at Sam's Point about the possibility of holding this meeting there, as we did a year ago. However, it was felt that until we have the completed map of Shingle Gulley ready to present, we should hold off on that. I did speak with Chris Goodman, the cartographer, at the Fall NRO, and he will prioritize this so we can go and present it at an upcoming meeting.

We've had a lot of progress on the Merlins Cave acquisition, and I've participated with the other EC members and Chuck Porter in discussions and strategizing in moving that along.

Similarly, the EC has discussed the potential acquisition of Bensons Cave, which is dependent on the current trustees reaching resolution over the transfer.

One bothersome item for the EC and several of our preserve managers has been a rash of vandalism at several of the preserves. How we respond to those incidents, our communication with local law enforcement, and perhaps with the public in general may be something we need to discuss as a Board.

As VP, I've also been part of the routine office and budget discussions, as well as the recruitment of people to fill some of our vacancies, and the proposed bylaws amendments.

Of course, WNS still remains a huge focus for me. Much of the attention over the summer has been focused in the mid-West and far West. With much land out west owned by federal agencies, the management of caves and mines on those lands by the agencies is a higher profile than in the East. I've participated in numerous conference calls, meetings, and email discussions with cavers and agency personnel working on these issues. Research progress, Congressional funding requests, the Colorado NSS Convention, and many other local or regional WNS items took plenty of my time.

Probably the most significant matter for all of us to pay attention to in the immediate future will be the posting in the Federal Register of a draft WNS National Plan. This was delayed from posting back in June, but is apparently nearing a publication date. All of the affected federal agencies have been working behind the scenes to reach agreement on the draft document. The Federal Register publication will be the time for public input, and it will be critical that we all weigh in at that time. The NCC, as a cave conservancy experienced in dealing with WNS should file formal comments, as I believe they will carry some weight.

Finally, I just returned from a trip to California earlier this week, where I was asked to give two lectures on WNS. Both took place at the USGS facilities in Menlo Park, just south of San Francisco. This is a fascinating place – headquarters for the nation's seismographic research and monitoring. The San Francisco Bay Chapter of the NSS played host. Of specific interest to the NCC would be my visit to the Weller Preserve, location of the Western Cave

Conservancy's Rippled Cave. I spent time in the cave and with officers and members of the WCC, seeing their property and facilities, and discussing their cave conservation activities. I'll talk a little more about this at the meeting.
