  - On 5/12/12 a register was placed at the info Kiosk for Bentleys Cave as per the management plan.
  - 5/12/12-11/10/12 -- 25 groups with a total of 82 people signed in/out using the register during this six-month period.
  - Two entries reference a geo cache located on the property. These people are visiting the preserve to geo cache
    only and did not enter the cave.
  - On 11/10/12 a Cave Rescue Informational Presentation was held at the Berlin Fire Department for local Fire and Rescue personnel with Greg Moore (NCRC Instructor) and Jonah Spivak (Bentleys Cave Preserve Manager) presenting. After the presentation, a tour of the property and Bentleys Cave was given to several members of the Berlin FD. The Berlin FD also volunteered for, and completed, the removal of several trees that had fallen over the access trail during the past year, and from the recent storm "Sandy." This represents a terrific level of communication building and cooperation between the NCC and local first responders for the Bentley's preserve.
  - A fair amount of garbage was removed from the cave... a number of gatorade bottles, whiskey bottle, flare, cyalume stick, broken glass. New graffiti was also found. I believe this represents an increase from previous years. I suspect it is locals based on the nature of the trash, and I wonder if signage inside the cave stating NY cave law and penalties for damage to caves might help this problem. I'd appreciate feedback from the board on this issue, as to whether or not such signage would help.

Family Life members pay a onetime membership fee determined by the Board. If the Life member dies, the Family Life member shall automatically be converted to regular Life membership. If the marriage or civil union is dissolved, the Family Life member may convert to full Life by paying the difference in dues amount currently in force.

The Life and Family Life Membership fee may be paid over three (3) years in equal installments in addition to paying the basic Regular or Family dues fee, respectively.

Discussion: While sending out the most recent batch of membership renewals and thank yous, one NCC member inquired if there was a Family Life membership option. I had to tell him we currently have such a thing.

However, we have a number of couples where one is a Regular member, the other Family. If the Regular member chose to become a Life member (\$300, or 20 x the annual membership fee), they would still have to continue paying an annual \$5 fee to continue the Family membership for their significant other or minor children. I can easily see where, simply as a matter of convenience, they would like to also make a one-time payment to have a Life Family member as well. If we did the same math (\$5 x 20), we'd have a fee of \$100 for this new category. The question then becomes what to do when the underlying Life member dies or the parties break up. It seems a nice gesture to transfer the full Life voting privileges to the survivor, plus, we already have the money. If the couple breaks up, the former Family Life member can simply pay the difference and become a Life member themself (in this case, paying the additional \$200). But maybe they don't want to. They could alternatively simply join as a Regular member, or

maybe they don't want to be a member at all. In either of those scenarios, I don't think it needs to be addressed in the Bylaws. So, I propose the bylaw and Act amendments for consideration.

## Purpose

The purpose of this trip was to survey the hibernacula and install data-logger devices (Maxim iButtons) within areas of the cave used by hibernating bats. Initial environmental samples were also collected.

#### **Events**

- 73 data-loggers in 1oz plastic cup shields were installed in three regions of the cave. Region 1) the New Discovery prior to the crawl; Region 2) throughout the first large sloping room in the Lakeroom Maze section; Region 3) throughout the adjoining sloping room in the Lakeroom Maze. The dataloggers were attached to the cave walls and ceilings using florist wire or nails wedged into preexisting cracks.
- Environmental samples (cave surface swabs or soil samples) were collected at each data-logger location. A total of 61 swabs and 12 soil samples were collected. These samples were shipped to the lab at NWHC to be analyzed for *G. destructans*.
- 5 data-loggers were mounted on metal stakes, 1 near the entrance to the cave and 4 in cardinal directions approximately 20 meters from the entrance. These will provide external environmental data for comparison to internal conditions.

#### Summary and Follow-up

The initial set-up and sampling interval for this project were completed successfully. We greatly appreciated the assistance of our caving guides and enjoyed the challenges and natural beauty of this cave. We will be coordinating the next sampling intervals with Carl Herzog and Bob Simmons, tentatively scheduled for November/December and March/April.
